Personal data that we process

Casa Rea processes your personal data because you book a holiday accommodation with us or you have registered to receive the newsletter. Below you will find an overview of the personal data we process:

- First and last name
- Address (street, house number, zip code, place of residence)
- Phone number
- E-mail address

Special and/or sensitive personal data that we process

Our website does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardians. However, we cannot check whether a visitor is older than 16. We therefore recommend that parents be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this consent, please contact us at info@casarea.eu and we will delete this information.

For what purpose and on what basis do we process personal data?

Casa Rea processes your personal data to process your booking and invoice for this booking. In addition, the data is used to send the newsletter. Your data is also administered to comply with our legal obligations (financial administration).

Automated decision making

Casa Rea does not make decisions based on automated processing on matters that could have (significant) consequences for people. These are decisions taken by computer programs or systems, without a human being involved (for example an employee of Casa Rea).

How long we keep personal data

Casa Rea does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods for the following personal data:

Sharing personal data with third parties

Casa Rea only provides data to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Casa Rea only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use enable us to optimize our own website. You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser.

View, adjust or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to data processing or to object to the processing of your personal data by Casa Rea. You can send a request for access, correction or deletion of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@casarea.eu. We will respond to your request as quickly as possible, but within three days.
